## Terms and Conditions

1. The firm should have a registered office in the state of consignee. **(i.e. at A&N Islands)**
2. The firm should have a minimum annual turnover of **Rs. 23,618/-** for the last three years each i.e., **2022-23, 2023-24 & 2024-25** (MSME relaxable) to be eligible for participation in the bid. Firms will have to submit audited financial statement for the above for the last three years in support of annual turnover.
3. The firm should submit the past experience of similar type of work under govt. organization.
4. Audit of accounts of the ANSAS should be carried out as per the **sanction order wise & release wise of grants**, and also as per nature of the grants i.e., recurring and non-recurring.
5. Audit of PMU, ANSAS, Sri Vijaya Puram, should be completed within 7 working days from the date of commencement of the work (Sl. No. 10 of ATC will be applicable).
6. Audit of Ayush Accounts of **District Health Society (South Andaman, North & Middle Andaman and Nicobar)** should be completed within 30 days from the award of work (Sl. No. 10 of ATC will be applicable).
7. Audit reports should be submitted by the Auditor firm along with five supporting documents **(i.e., Utilization Certificate, Statement of Expenditure, Achievement cum performance report, certificate of non-availing, Statement of Asset)** within 30 days from the award of contract.
8. The work completion certificate will be issued only after the acceptance of Audit reports of the ANSAS by the Ministry of AYUSH, Govt. of India. In case of any modifications required (as may be sought by the Ministry of AYUSH, Govt. of India) for the submitted audit reports, the Audit firm needs to give the revised reports as sought by the Ministry without any extra charges. The Mission Director (ANSAS, NAM) reserves the right to accept or reject the whole or part of work order with assigning valid reason thereof.

9. Performance security at the rate of 3% of the amount quoted should be submitted by the successful bidder in the form of FDR/Bank Guarantee drawn in favour of A&N State Ayush Society, Sri Vijaya Puram. The Performance Security should be valid for a period of fourteen months.
10. **Liquidated Damaged & Penalty:** The firm will be bound to execute the work within the stipulated period, failing which the penalty of 0.5% of the total value of contract per month from the due date of completion of the audit.
11. **Arbitration:** In the event of the any dispute or difference relating to the interpretation terms application of the provision of the contract, such dispute or difference shall be referred by either party for Arbitration to a sole arbitrator to be appointed mutually by the parties. In case parties fail to appoint the sole arbitrator within 30 days of the invocation of arbitration, the same will be appointed as per the provision of the Arbitration and Conciliation Act, 1996 (as amended). The language of the arbitration shall be English. The place where the concerned office of conducting the tender is situated shall be the venue of arbitration proceedings. The cost of arbitration proceeding will be borne equally by the parties to the arbitration. The award of arbitration shall be final and binding on the parties.
12. **Jurisdiction of Court:** Nothing in this contract shall be held to exempt the contractor or his agents, staffs and workers from liability of civil or criminal proceeding or both for any breach of this contract or of any offence committed by them and all disputes arising out of this contract shall be subject to Jurisdiction of Courts at Sri Vijaya Puram.

## अस्वीकरण/Disclaimer

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization, whereby Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specifications and / or terms and conditions governing the bid. If any clause(s) is / are incorporated by the Buyer regarding following, the bid and resultant contracts shall be treated as null and void and such bids may be cancelled by GeM at any stage of bidding process without any notice:-

1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.
2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to exemption provided to such sellers under GeM GTC.
3. Publishing Custom / BOQ bids for items for which regular GeM categories are available without any Category item bunched with it.
4. Creating BoQ bid for single item.
5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
7. Floating / creation of work contracts as Custom Bids in Services.
8. Seeking sample with bid or approval of samples during bid evaluation process. (However, in bids for [attached categories](#), trials are allowed as per approved procurement policy of the buyer nodal Ministries)
9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.

10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
11. Creating bid for items from irrelevant categories.
12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
13. Reference of conditions published on any external site or reference to external documents/clauses.
14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.
15. Any ATC clause in contravention with GeM GTC Clause 4 (xiii)(h) will be invalid. In case of multiple L1 bidders against a service bid, the buyer shall place the Contract by selection of a bidder amongst the L-1 bidders through a Random Algorithm executed by GeM system.
16. Buyer added ATC Clauses which are in contravention of clauses defined by buyer in system generated bid template as indicated above in the Bid Details section, EMD Detail, ePBG Detail and MII and MSE Purchase Preference sections of the bid, unless otherwise allowed by GeM GTC.
17. In a category based bid, adding additional items, through buyer added additional scope of work/ additional terms and conditions/or any other document. If buyer needs more items along with the main item, the same must be added through bunching category based items or by bunching custom catalogs or bunching a BoQ with the main category based item, the same must not be done through ATC or Scope of Work.


