B. TIME PERIOD OF ENGAGEMENT

The selected CA will be required to provide the above mentioned services as specified in Scope of Work initially for the period of one year when will be awarded the contract in the financial year 2026-27 and may be further extended for another two years on year to year basis on the basis of satisfactory performance of work.

C. PRE QUALIFICATION CRITERIA
